## **RULES:**

- All entries must be received by May 26, 2019
- A list of ride times will be posted Pinewood Acres Facebook page as well as emailed to those who provide an email address on entry form by the Monday before each show.
- Riders must wear an ASTM/SEI-approved helmet while mounted on a horse anywhere on the grounds.
- Riders must also wear a long or short-sleeved shirt of solid/conservative color (without neckwear and without design or writing), breeches of solid conservative color (black, blue, white, beige, and gray), riding boots, tall or short, with heel and of a conservative color. Half chaps of solid color are allowed. Formal jacket not required.
- Exhibitors may carry one (1) whip of length no longer than 48 inches including lash.
- Alternate bits may be used for safety purposes only. Judge must be notified prior to test. Judgment on bit at judge's discretion.
- A current Negative Coggins is required at the Secretary's stand or must be on the NPHA Master Coggins List.
- Dallas Equine Center, LLC d/b/a Pinewood Acres, the Show Committee, Soaring Saddles 4-H Club, the volunteers, Luzerne County Fairgrounds, and/or NPHA will not be responsible for any loss or injury to any person, horse, or property incurred on any of the show grounds.
- The show committee reserves the right to make any adjustments necessary to make the show run in a timely manner.
- All dogs must be leashed on the fairgrounds.
- All Equine activities are pursuant to PA Equine Law Act 93 of 2005.
- The show ring is 200' x 270' enclosed by vinyl fencing with sand footing. The warm up area is sand footing.
- Bedding is not provided in stalls, please bring your own. Stalls must be cleaned upon departure!!

- From I-81 N or S; Take exit for RT 309N for approx. 10 miles; at Dunkin Donuts (on the left side) stay straight for RT 415N (Weis market will be on the right side) go approx. 3 miles; At Luzerne Bank make left turn onto RT 118W; Go 1/8 mile then turn LEFT for GATE B of fairgrounds on to Yalick Rd. Entrance to show grounds is ¼ mile on right.
